## CONDITIONS OF ENTRY

- Open to any artist who resides in Southland, Otago/Central Otago and RCAC members.
- Entry limited to one piece per artist.
- All works must be the original, unaided work of the entrant and completed in the last year.
- All artworks are subject to our selection process. Painting, drawing, sculpture, graphic art, photography, jewellery and ceramics are all eligible for entry.
- Works MUST be totally dry, professionally presented and ready for hanging or display (with d-rings 75mm from the top and strung).
- Once works have been unpacked, a condition report will be undertaken and any concerns noted.
- The longest side of the artwork must not exceed 1200mm (including frame). 3D works: maximum of 1500mm on the longest side. Works outside of these dimensions will not be selected.
- Artist's name as for catalogue, title or work, medium and price must be on back of work as well as on a swing label.
- The organisers reserve the right to photograph selected artworks for publicity relating to the exhibition.
- All artworks must be for sale. Commission will be 30% for non members and 25% for RCAC members.
- Collection of any unsold artwork is the responsibility of the artist and must be collected by Sunday 10th May between 3-5pm.
- Insurance during transit and at the exhibition are the responsibility of the artist. Every effort will be made to ensure that all work is handled with the greatest of care.

## SELECTION - JUDGES

The Judges' selection will be final and no correspondence will be entered into. Artists will be notified of acceptance or non-selection.

A judge for the Preston Russell Law Art Awards will announce the prize winners on Friday 10 April 2020.
